Legislative Watch Update

One of WPA's main functions is Legislative Watch. WPA's Legislative Watch Committee, comprised of volunteers, is constantly on the lookout for potential issues that would have an impact on Wisconsin homeschoolers. Through vigilance and hard work we watch, inform, and ask for action when needed. In this way, we are able to head off many issues that could become problematic for homeschoolers before they get a foothold. Federal and state legislature and administration changes

2019 marked the start of a new Congress, as well as a new administration in Wisconsin. In the midst of all this, there are efforts to change education laws and policies, some of which may affect homeschoolers. In addition to monitoring these changes, here are some of the issues our Legislative Watch Committee is keeping on top of:

The Wisconsin 2019-21 biennial budget

The 2019-21 biennial budget process is underway, and the Legislative Watch Committee is monitoring the process for any provisions which may affect homeschoolers. (As a reminder, the sports and homeschool diploma legislation were introduced in the 2015-17 budget cycle as amendments.) WPA will inform you of any action which may be needed.

H.R.65 and H.R.621/S.157 are still pending

Each of these bills would amend the Internal Revenue Code that permits kindergarten through grade 12 educational expenses to be paid from a Section 529 education savings account to be expanded to include qualified homeschooling expenses. The previous times this proposal was presented, many homeschoolers (including WPA) did not support this change and the legislation was either revised to remove the homeschool provision, or the legislation did not pass.

Why is this legislation a problem for Wisconsin homeschoolers?

The biggest concern for Wisconsin homeschoolers is that this allows the federal government to determine what is considered an educational expense by creating guidelines for defining a "qualified expense."

In other states, where homeschoolers have to use state-approved curriculum or specific standardized tests, this may not seem like a problem. However, in Wisconsin, homeschooling parents/guardians are administrators of their homeschool and they alone determine what is considered educational and what type of curriculum they include in their homeschool program. This bill threatens to define what is considered a legitimate homeschooling expense, limiting the freedom of homeschoolers in Wisconsin.

In addition, if homeschoolers took advantage of this program, they would have to answer to the federal government as well as the state government to show that the homeschooling expenses they claim are acceptable.

If you have not yet done so, please take a moment to contact your U.S. Senators and your U.S. Representative and let them know that homeschoolers do not support H.R.65 and

Quick facts on the QAC

Q What is the QAC?

A The Question Answering Committee (QAC) responds to questions received via the WPA voicemail ((608) 283-3131) and email (questions@homeschooling-wpa.org).

Q When did the QAC start?

A This committee was formed in June 2018, and replaced the former Regional Contact system.

Q Who works on this committee?

A Currently at six volunteers, including the QAC coordinator, our QAC members are all former Regional Contacts, who take turns answering questions.

Q Do the QAC committee members get paid?

A LOL!

Q What kinds of questions are received?

A Anything related to homeschooling, and some topics not related to homeschooling! For example, we regularly receive questions on how to begin homeschooling, questions on how to choose curriculum, questions about high school, and questions about record keeping. We have also received questions on how to transition from a traditional school environment to homeschooling, and have been asked to help with special situations, such as where to find the instructions for filing the necessary school paperwork for Social Security survivor benefits.

Q Where does the QAC get the information to answer questions?

A The volunteers who make up the QAC are experienced homeschool parents.



Most have been involved in supporting other homeschoolers for several years. Many questions can be answered with the accurate information available on the WPA website. For "trickier" questions, the QAC members consult the QAC coordinator to make sure the answers given are accurate.

Additionally, the committee meets at least once a year for further discussion and training.

Q Why would anyone volunteer for this committee?

A We asked our QAC volunteers, and here are some of the responses we received:

"I do all that I do, including volunteer for the QAC, because I have a love for the homeschooling community that includes making sure they are getting thoughtful, accurate information. I love being a source of encouragement to fellow homeschoolers, to those just learning the ropes, and to those who are trying to decide if homeschooling is the route they want to go. So, even when I have answered the same question for the bazillionth time, I still don't mind doing it because I know it is not just helping that person, but then they will have accurate information to share with their friends as well."

"I work on the QAC to deepen my understanding of homeschool law as well as share correct information with all homeschoolers. I work (continued on page 4)

H.R.621/S.157. (Since these are all federal legislation, there is no need to contact your State Senator or Representative at this time.)

Contacting your legislators

IMPORTANT REMINDER: If you have not done so yet, please contact your state and federal representatives, as WPA asks at the beginning of each year. When you do this, please:

- Be respectful. Even if you disagree with your elected official, there is often an opportunity to find common ground and thank them for something they have done that you do agree with.
- Let them know that you are a homeschooler and their constituent.
- Share with them that homeschoolers in Wisconsin want to preserve our good

homeschooling laws.

- Be clear that homeschoolers DO NOT want anything from the State (especially funding, tax breaks, and/or to be treated like a special interest).
- Be willing to answer questions about homeschooling or refer them to the WPA website.

This is one of the most effective things homeschoolers can do to preserve our current homeschooling freedom. If elected officials know that their homeschooled constituents do not want legislation, they may be less likely to introduce a bill about homeschooling and/or more likely not to support a bill if introduced by others.

to strengthen law-abiding homeschooling in Wisconsin so all homeschoolers can benefit and the current Wisconsin homeschool law may be maintained. I work with the QAC because I value the Wisconsin Parents Association. I am grateful for the organization, the work it's done, and the experienced volunteers that make it a reality."

"I want homeschooling to be an option for the next generation. None of my grandchildren live in Wisconsin, but I want the option for all the grandchildren who do live in Wisconsin. Unless we have a clear understanding of the incredible law we have, and work to maintain the law as it is written, the law will be altered. We must remain vigilant to maintain this educational option. If the

law is changed, we will no doubt lose flexibility to tailor homeschooling to best suit each child in each family. Every child, every family, is unique. It is a privilege to express that uniqueness through our approach to education."
